6. Public Participation:

Ms. Schratz said that the public was invited to participate by submitting questions and comments via the weblink. She asked the Board Attorney to read all questions and comments submitted by the public.

Mr. Brisman read the following comments/questions:

Nilda Carrera, 321 Broadway

Here are some suggestions for remote learning. Could a few min be added in between classes or teachers be asked to finish at least 2 min early? Many students have trouble toggling between classes or get shut down trying to do so. To then minimize login issues due to too many users, can Math and ELA, at least, be split either by level or randomly so that there are less students at one time and they can get more focused learning. The protocol of full instruction per period works in person, remotely I feel needs to be changed. Many parents feel their children aren't learning. Most are synchronously learning all day. It seems like their asynchronous work ends up becoming HW because the teachers can't get through their lesson. Is this something you could consider for classes with more than 15 students? Thank you.

Antonio Curtis, 80 Passaic Avenue

It is a little nerve wrecking to see the letters of all the positives in the school when kids are not in the school. I wonder if maybe the procedures need to be looked at or if there is a lack of enforcement? How much staff are in the schools right now? Can we reduce the numbers more? Makes no sense for all the custodians to go to the schools everyday.

The biggest complaint that I see online from parents and I have to agree with is the amount of time spent in front of the screen. Are there any plans to reduce time on the computer? This will also help for the students who have to help younger siblings and computer problems for families with bad internet.

Can you explain what reconnect time is? Some teachers say that it is required for students to come and some teachers are saying that students only need to go when they need help.

When are we going to fill the Assistant Superintendent position? Seems like an important position to have and its been open for like half a year. If its not needed does that mean that the years we had one was wasted money?

To those parents that want their children go back to school or decide that they want their kids to go back to school moving in phase 2, do they also have to do virtual learning right after they come out from school?

I am worried for my daughter who is suffering from anxiety, stress and having severe headaches due to the difficulties and problems with technology and the short amount of time she has to turn in completed work, some of which she does not understand and has difficulty with. She did not have these problems the previous year. What can we do for our children. I am a worried mother. Thank you for your understanding.

Good Evening. The past seven months have not been easy for anyone. I also realize that many very difficult decisions had to be made and everyone has to carry extra responsibility. So please understand, I am not trying to second guess anyone, just expressing my disappointment.

1. Back-to-School Night - I had thought that our Back-to-School Night would be virtual. Though I see many of my parents and guardians during the school day via my Google Meet, I do not see all parents. Also, the Google Meet is instructional time and does not afford me the opportunity to answer parents or guardians questions. I had looked forward to meeting with my parents, albeit, virtually, it would have been their time to ask questions, make suggestions or bring important concerns to my attention. Instead of meeting virtually, we were directed to make a video to welcome our families to our classrooms. This endeavor took many hours to produce a less than ten minute video. I don't know why a video was chosen over a Google Meet, but I can say that the many hours I spent making it, I would have preferred to use that time developing lessons and instructional materials for my students. As I said at the beginning of my statement, we are all carrying an added load, parents, students and educators, so adding to an already onerous load by making a video was a difficult pill to swallow.

2. Daily Student Attendance - During in-person instruction, attendance is taken first thing in the morning as the students are settling in, eating breakfast and morning announcements and exercises are taking place. It is a bit different now because I am seeing my students on the computer. So I switch screens quickly and take attendance, but now there are two additional steps I must take, as I complete two additional documents for any students who are not present. These additional steps take me away from my students. I am not the only homeroom teacher who feels this is an additional burdensome task. In some schools, homeroom teachers are also asked to make phone calls to parents, which again takes away from our instructional time. It is important to monitor students who are not connecting with their teachers, but if there is a way to remove those two additional responsibilities from the homeroom teachers, it would be greatly appreciated.

Maritza Deschamps-Soto, 337 Berkeley Avenue, Floor 1

I'm a preschool teacher in Passaic. My classroom parents want to know what's the reopening plan going to look like in a preschool classroom? They have seen mock classrooms in the news of upper grade levels but none of a preschool classroom. They are expressing lots of concerns to this matter. They also wanted to know if temperature scanners are going to be available in all the school buildings like the ones located in City Hall? How are the preschoolers going to be received into the school building since parents aren't no longer allowed into the school buildings?

I thank you in advance on behalf of all my students and classroom parents.

Mr. Muñoz thanked all the teachers, parents and administrators for all the work they are doing during the full-time home-based instruction. He said it is not an ideal situation but it is the only way to keep staff and students safe during this time of pandemic. He thanked the public participants for their comments and suggestions, saying they will be reviewed with administration. He deferred to Mr. Truppo to explain "Reconnect Time".

Mr. Truppo explained that Reconnect Time is done at the end of the day. The teacher can use it for a variety of tasks depending on the needs of the teacher and student. For example, pre-teaching an upcoming lesson, continuation of a lesson or to assist students who may be struggling with a particular concept or lesson. Mr. Truppo said he is working with a committee of teachers and the President of the EAP to continue discussions on making enhancements to Reconnect Time.

Mr. Muñoz said a staff member would reach out to the parents who had questions or comments regarding their particular child's circumstances to see how assistance can be provided.

Mr. Muñoz said that district has purchased hand-operated devices to take temperatures from a distance.

Mr. Muñoz shared that when the district enters Phase 2 or Phase 3, the preschool classroom size will be at 25% room capacity as per the Governor's Executive Order. If the Executive Order is lifted, then the district will follow the guidance of the Department of Education, which uses a calculation of 113 square feet per person. An analysis of the district classrooms was done and we know how many people can occupy each space.

Ms. Sanchez asked if the Reconnect Time committee that Mr. Truppo is working with would discuss the parents' concerns regarding students' workloads and connectivity issues. Mr. Truppo responded that the topics have come up in past meetings and will continue to be discussed. He said there is also a work group of principals that is working on screen time issues. He shared that parent focus groups have also discussed screen time, but it is a delicate balance, as teachers need to work with students.

Ms. Sanchez inquired as to the status of the Assistant Superintendent's vacancy. Mr. Muñoz responded that it is a personnel matter and could not be discussed in public; however, the process is still ongoing.

8. Report of the President

President Schratz acknowledged the following events/activities that have taken place:

- Ms. Schratz, together with several Commissioners, visited nine schools in early October. Additional visits will be conducted in the future to see the school preparations taking place in our district.

Ms. Schratz thanked the parents, teachers and administration for all of their work during this time.

9. Report of the Superintendent

Mr. Muñoz shared that on the personnel section of tonight's agenda there is a resolution to accept the retirement of Ms. Erlinda R. Arellano, School Business Administrator and Board Secretary. He said that while it is sad she is leaving, he wishes her a happy, healthy and joyous retirement.

All board members expressed words of congratulations and thanks to Ms. Arellano for her hard work, dedication, and leadership in the district and wished her a long and healthy retirement.

Ms. Arellano thanked the Superintendent and the Board Members for the many opportunities, the support, trust, respect and friendship that were given her during her time at the Passaic Board of Education.

Mr. Muñoz shared the following report regarding the School Restart and Recovery Plan:

Later this evening, as reflected in the board agenda's Authorization Report, the Passaic Board of Education will vote on the District Operations committee, Curriculum and Education committee, and my recommendations that the Passaic Public Schools continue to operate in Phase 1, Full-time Remote Home-based Instruction, from now through February 5, 2021. The date of February 5, 2021 is the end of the second marking period.

The Board of Education and the district administration will continue to monitor the health and safety conditions, statutes, and executive orders during the months of November, December, and January. In January 2021, the Board of Education will decide whether to continue in Phase 1 (Full-Time Remote Home-Based Instruction) or enter Phase 2 (Hybrid Instruction - One Session Day) on February 8, 2021. The date of February 8, 2021 is the beginning of the third marking period.

During Phase 1, Full-Time Remote Home-Based Instruction, the school buildings will continue to be closed while all students and staff work remotely from home. The Board of Education's decision to continue in Phase 1 is based on COVID-19 tracking data and the input from families, staff, and medical experts. The Board of Education met in two committee meetings on October 15, 2020 to review guidance from our local health officials and Hackensack Meridian Health Systems consultants; and survey results from more than 1,800 staff and families of over 10,000 students. I thank the staff, parents, community members, medical experts, and the Passaic Board of Education for their contributions and support.

Our Board of Education and I recognize and appreciate the efforts of our staff and families as we work to stay safe and healthy during the COVID-19 pandemic. I thank you for your understanding as this public health crisis continues to impact our entire community
