# 1. Approval of the 2023-2024 School District Budget for Submission to the New Jersey Department of Education/Executive County Superintendent of Schools

Recommends that the Passaic Board of Education pursuant to N.J.S.A. 18A:7F-5(c) and N.J.A.C.6A:23A-8.1(a) recommends the proposed school budget for the school year 2023-2024, as prepared by Mrs. Sandra Montañez-Diodonet, Superintendent of Schools, be approved for submission to the New Jersey Department of Education and the Executive County Superintendent for Passaic County for review and approval.

The proposed school district budget as introduced by Mrs. Montañez-Diodonet highlights the following:

Total School District Budget Appropriations \$392,108,536

Less: Anticipated Revenues \$ 375,289,959

Minimum Tax Levy for Passaic Taxpayers\* \$ 16,818,577

\*The Minimum Tax Levy of \$16,818,577, reflects a zero percent (0%) tax increase over last year's budget.

The budget to be submitted to the New Jersey Department of Education and to the Executive County Superintendent of Schools for review is subject to possible adjustments and revisions. The proposed school budget is subject to revisions by the Passaic Board of Education. Budget discussions and review are ongoing through the month of March. The budget will be advertised in accordance with N.J.S.A. 18A:22-10.
